OSHA called Gary with concern over the scaffolding at 106 Main Street. 2) He issued a violation for a shed that was thrown together using doors and various pieces of wood on Chestnut Street. 3) Gary met with Town Highway Supervisor Rocky Kohlbach and Town Deputy Supervisor Bill McIntyre at the town barn to discuss the issue of the sand needing to be removed from the floodplain area. The Village has sent several letters and the DEC will be fining them if they do not comply. Rocky assured Gary that he will have the workers working on that immediately. 4) Trustee Jim asked if letters have gone out to residents who have chickens. The clerk stated no, a first draft list was discussed and the clerk was directed to start with that.

Streets Report, David Decker present - 1) Budine Tree Service gave a quote to remove trees by Don Hayes and Tom Phillips home. At Don Hayes home, removal of the large white pine is \$1200 and the medium white pine is \$700. At Tom Phillips house, removal of the dead spruce is \$550 and the removal of the spruce on the corner is \$550. Total cost is \$3000.
