Code Enforcement Report, Gary Post present - 1) The owner at 23 Main Street wants to know if he can make the building into a one family home. Gary stated yes, but there are many requirements that would have to be met. 2) Gary is sending a letter out to the owner at 185 Main Street stating that it has been over 3 months since she was sent the violation. 3) John Benson from Susquehanna contacted Gary because he is buying Ken Wild's place. He wanted to know if he could tear down the buildings. Gary stated that he would have to have a demo permit. He asked information about building and Gary stated that in order to build anything, he would have to have a 239 SEQR and have to contact the DEC and there would be many restrictions because it's in the flood zone. He stated that he may be considering fixing one of the old buildings up and Gary told him he would still need to meet requirements as it is in a flood plain. It is a commercial zone. 4) Gary will be sending out a violation for Bridge Street. He has to do it fairly.

Attorney's Report - A report was submitted.

Streets Report, David Decker present - 1) The Christmas lights will be taken down this Saturday. 2) The plow frame on the dump truck was rotted and cracked during one of the storms. It was taken to Burr Trucking and they replaced a portion of the frame and also reinforced part of the existing frame. It cost about \$600 and we should get that money back out of it when we sell it. 3) The little Kubota has been acting up. It will not shut off when you turn the key off. You have to reach in by the fan and push lever to get it to shut off. We replaced that part last year and will have to replace it again. There was a shorted wire that burned up on it this week where it couldn't start. Today when doing the walks, it wanted to stall out while it was in gear and he had to keep playing with the high low range lever to keep it running. He doesn't know what the problem is other than maybe the cold. 4) During one of the storms, the dump truck quit running, batteries died. Steve at JF Auto checked the battery and the alternator. We changed the aviator spot lights on the salt spreader with LED's and haven't had a problem since. This has also happened in the past years. 5) I've been working on specs and pricing for new dump truck, currently that series dump truck is not on state bid. Dave's been working with Chenango Sales and a couple other dealers right now and getting a prices on a 450 and we may even want to go to a 550. The 350 we have is just too small and it's weighted down too much with the salt spreader.

Water Report, David Decker present - On the 29th, David noticed that a fire hydrant was bent over down by the train shop. It snapped the bolts. Everything on it is still good. He has someone coming down to look at it to see if it's repairable. 2) This past Saturday, he got a call about 3:00 a.m. that we have a water leak on the corner of Grove Street and Gary Drive. We lost approximately 150,000 gallons. We didn't lose pressure so a boil water advisory was not needed. Colwell Brothers were called to help. There were several driveways that were solid ice because of the leak so David tried to clean out the end of the driveways and also salted them.
