**Public Comment** - Patrick Root from Boy Scout Troop 68 was present and Ron & Sue Rambo. Mayor Harting thanked Steve for staying with the Village, in light of his new position at the zoo. Deputy Mayor Skinner gave Steve some donuts and asked him to stay.

Grant Writer Report - 1) Steve is pursuing a Restore New York Grant for the railroad station. 2) We are waiting for the records management grant with the town. Randy is getting the walls ready for the shelving that will be coming. 3) The DEC Grant sent the village the money for the grant. Not all of it was used, so we may have to send some of it back. 4) He has started putting the paperwork together for the shared fuel depot. He looked at the Binghamton fuel depot and we may want to model after. The county may be willing to also go in on the shared fuel depot grant. The school offered some tanks.

Code Enforcement Report, Gary Post present - 1) Gary received a call from a tenant who was moving out of one of the apartments on Main Street. There were several violations. Gary has been in touch with Mike Livolsi, an attorney from Syracuse. A court date was set for the two properties that have gone to court. Gary needs to know how hard the village board wants to push on this. The one property may end up in the village hands. The other one is not structurally sound. Trustee Skinner is looking for all of our expenses being covered and have the buildings brought into compliance. Trustee West agrees.

**Attorney's Report** - Beth submitted a drawing of the parcel at 117 Main Street with the right-of-way on the property. Mayor Harting suggested we meet sometime this month to discuss if we want to move forward.

Streets Report, David Decker present - 1) The dump truck plow is over to M & C Truck. It will cost about \$1000 for repairs. 2) Due to lack of snow, we're running way behind on our salt purchase. We need to purchase 60,000 tons more to meet our 70% purchase. 3) The John Deere is back running after fixing the spindle. 4) The dump truck tires have been recalled. He's waiting for the paperwork to come through.

Water Report, David Decker present - 1) The new chlorine pumps were installed last week. We're waiting for one gauge to come in. 2) The CCR Report is ready to be mailed out. It's been approved by the Health Department. 3) We're running high on water usage, approximately 15,000 gallons a day. They've been out checking but will continue to look for a possible leak. David was instructed to get meters into the unmetered places, such as the town hall, community house, town highway department and the fire company. He said the location of the pipes in the fire station may make it difficult to put a meter in but he will try. 4) Rocky will be bringing his excavator over to put the water line in at the railroad station on possibly Thursday. Once that is done, Roger Peet can go in and put in the toilet. 5) David asked that the clerk put the CCR Report on the village website.

#### **RESOLUTION NO.16-2012**

RESOLUTION AUTHORIZING THE ISSUANCE OF A BOND ANTICIPATION NOTE FOR THE PURPOSE OF MAKING ASSESSIBLE CAPITAL IMPROVEMENTS TO THE EXISTING PUBLIC WATER SYSTEM OF THE VILLAGE OF WINDSOR (RENEWAL)

**WHEREAS**, the Board of Trustees of the Village of Windsor, by resolution dated March 6, 2012 authorized certain assessable capital improvements to the Village's public water system; and

**WHEREAS**, the Board of Trustees previously authorized the issuance of bond anticipation notes in anticipation of the sale of serial bonds and the current bond anticipation note matures on March 30, 2012,

**NOW, THEREFORE, BE IT RESOLVED,** this 6<sup>th</sup> day of March, 2012 by the Board of Trustees of the Village of Windsor, located in Broome County New York, that the bond resolution dated March 6, 2012, be renewed and that the bond anticipation note dated April 1, 2011, which matures on March 30, 2012, be renewed for an additional year.

The renewal bond anticipation note shall be in the principal amount of \$22,500.00 together with interest at a rate not to exceed 2.15% per annum, shall be dated March 30, 2012 and shall mature on March 29, 2013.
