**Public Comment** - Present were Steve Herz, Sue Rambo, Ron Rambo, Fire Chief Craig Terrell, Elaine Card and Bill Wallick. Sue Rambo wanted to let the village board know that Elaine Card is now the president of the Windsor Partnership, Bill Pesce is the vice-president, Nikki Kulik is Secretary and the Treasurer position is open.

**7:15 P.M.** - Public Hearing for Fire Company Contract - Chief Craig Terrell was present to discuss the fire contract. There was no public comment. Both parties are agreeable to meet and discuss the budget of the fire company. Craig was asked if he could submit to the village a list of volunteer firemen. He said he would get us an updated list. The contract was signed by Craig and by the mayor. Ron asked why they have to have new members approved by the town board and not the village board. Craig stated that he believes it's because of the worker's comp. Craig said they are going to do possibly 4 chicken barbeques this summer and wants to know if there are conflicting dates. He would also like to do breakfasts during the winter months there.

Code Enforcement Report, Gary Post present - 1) Gary thanked Elaine for going to the ZBA training. 2) He had a tenant/landlord problem of no heat. He met with them and they discussed the issue to be fixed. 3) He issued a building permit for Locust Street. He's raising the house and filling in the basement. 4) We need to move forward with setting up a ZBA meeting for an issue that will be coming to them soon. Gary talked to the county planning and the county health department about questions they had regarding the appeal. 5) He spoke with Beth on the phone for about an hour about some issues and about the other possible appeal that may be filed soon. Beth is composing a letter at this time to send to the owner at 185 Main Street to tell her of her options. 6) Sent out a couple violations.

**Attorney's Report** - A report was submitted. Beth responded to the list of outstanding items that were sent to her. As noted in item #9, she will have code issues ready for the May meeting to present them and set up a public hearing for these items. Trustee Skinner had a question regarding #3. He asked if it was reliable for Delta to be doing the road use permit for all of the county.

**Grant Writer Report** - No report was submitted.

Streets Report, David Decker present - 1) David hopes to take the spreader off this week and start brush pickup, depending on weather. He asked for it to be put in the paper for starting the 15<sup>th</sup> of April. 2) Next month we will have to look at the street paving that needs to be done. 3) Next Monday we have a meeting at the Community House with the people from the Safe Routes to School. They want to look at the project site and the management plan. David asked Patti to contact Chris Durdon from the school, Alex Urda and Tom Murphy have them come.

Water Report, David Decker present - 1) Rural Water came down and helped find the leak by the factory. The leak is actually on Red Harvest Lane so they hope to fix it on Thursday or Friday because they will have to close off the street and school is not in session. 2) David would like to buy a leak detector. The one he has now has not picked up the last two leaks nor has it picked up any in the last two years. The new one he'd like to purchase is the same one that we had before but we lost it in the flood.
