1. Failure to get permission to tap or connect to a main distribution water pipe - Change from \$250.00 to \$1,000.00.

Chapter 194-29

1. Any person other than authorized personnel interfering with any water valve - Change from \$250.00 to \$500.00.

Chapter 194-30

1. Any person obstructing a valve – Change \$250.00 to \$500.00.

It was noted that Chapter 168-3 states that residents will be reimbursed up to \$200.00 for repair/replace. During the fiscal year 2010/2011, the board decided to change the amount that can be reimbursed to \$300.00. That needs to be changed in the code book.
