Public Comment - No public comment.

Code Enforcement Report, Gary Post present - A report was presented. 1) He's been working with the Main Street Grant. It's taking up a lot of his time. It's moving along. The due date is May 15th. The mayor will get in touch with Margaret from the Land Bank for a final date. 2) The Dollar Store is still going forward. He received new plans for the stormwater drainage. The sign permit was given to the contractor. 3) Talked to the contractor for 2 Pine Street and a couple of the electricians that are bidding on the job. 4) Did the 239 Review for 234 Main Street, the Bed & Breakfast. He spoke to Lora Zier from the Broome County Planning. As soon as we get the 239 back from the county, we will have to set up a meeting with the ZBA and the Planning Boards. Whether the project is big or small, it still entails the same procedure. 5) Sent out violations for 181 Main Street, 184 Main Street and 208 Chapel Street. 6) He had to do a code compliance letter for 13 Pine Street. That is something that is often asked for anymore. 7) We have to do a 239 Review for the sign law. Then we can have a public hearing on it.

Attorney's Report - A report was submitted. Trustee Tom asked why we are doing the PILOT for Leatherstocking. The mayor stated that he wanted our Attorney to take care of it. It's done now.

Streets Report, David Decker present - 1) The new mower is here. We'll be down to the park a lot as this weekend is Opening Day. 2) Broome Bituminous will be looking at Academy Street this month and give us a price. They are also going to look at the streets we want bid out. 3) They will be putting up the rest of the new signs this month.

Water Report, David Decker present - 1) The meters have been read. We need to order some more to replace some broken ones. 2) They will be looking for a leak next week. 3) Moulton's on Maple Avenue had Colwell's come in and fix a service line leak. 4) Mayor Ron asked where we are on the blow-offs. David said the salesman has not been back. He will try to get another company to deal with. 5) David put a call into TDS to put the

flags up on the side of the Community House. He'd like to have them up before Memorial Day. 6) Trustee Eileen stated she was concerned that we don't have all working fire hydrants. David stated that the fire hydrants all work. Some have more flows than others but they all can be used.

Treasurer's Report, Patricia Harting present - 1) A report was presented. 2) We received a quarterly sales tax. 2) The Senior Citizens at Windsor Woods wanted to know if the Village would refill the flower pots at the Center this year again. It was noted that money was put aside in the account for that item. Yes, they will. 3) The Wednesday Senior's would like to have a box with a lock on it built for them to put the coffee pot in. After much discussion, the board said they don't want all these little locked boxes all around the place. 4) The Garden Group wants to put in a cabinet in the dining area near the southwest corner. Currently the sound system for the band concerts is there along with chairs, a fan and a stand setup with a television and a dvd/vhs player. The board stated that they wanted to know what kind of cabinet they want there. We need to talk to someone from the band concerts to see how much the sound system and speakers are used. They may be able to be placed downstairs.
