Public Comment - No public comment

Code Enforcement Report, Gary Post present - 1) The judge gave the owner at 185 Main Street a fine of \$300. The owner paid. The check was given to the court where it was then sent to the state. There is interest in that house and the house next door being purchased for a possible retail store. Gary spoke with the Chairman of the Planning Board, the Zoning Board of Appeals and the village attorney. The prospective buyer asked if there was a contract, would the village hold off the penalty to the owner while it goes before the ZBA. Trustee Skinner asked if we could have any down payment put in escrow. Gary will check with Bob, the village attorney. 2) Robbie Hamlin opened up a motorcycle/atv/dirt bike shop in the other half of the building at 112 Main Street. He is just merchant sales, mostly internet. He cannot use it for a repair shop.

Streets Report, David Decker present - 1) Broome Bituminous will be out this month with the prices on the streets we can pave. 2) The county will be replacing the culvert pipe on Red Harvest Lane. They are changing it out. 3) NYSDOT will be doing culvert pipe and drainage work at Grove Street and Main Street, probably after school is out. 4) NYSDOT was walking and measuring the whole length of Main Street today. Where do things stand on the Safe Routes to School grant? The mayor stated that we have not heard anything recently.

Water Report, David Decker present - 1) We fixed the leak across from Patty Lee's house. It was a ring crack around the main. We were losing about 50-75 thousand gallons a day. 2) We have to repair a service line at Larry William's house. He noticed the noise after we fixed Lee's leak. Larry has offered to dig the hole for the village, as he already has it started. He won't charge the village for the work done. We will be doing it tomorrow morning. 3) We might have good news on the leak by Marian's. The Rural Water guy might have found an existing valve on the line. We just have to dig it up to see if there is one there. 4) Next Thursday we have a water meeting in Sidney all day.

Treasurer's Report, Patricia Harting present - 1) A report was submitted. 2) The Windsor Woods Tenants Association has disbanded so the check for \$300 was returned. They wanted to know if the village would still buy 2 planters that they purchase every year.
