Clerk Patti stated that she discussed it with David and the cost of the cans are over \$500 so David & Eric will try to make one this winter when they have time. Patti stated that the guys were awfully busy and don't have time to be emptying garbage cans everyday. Possibly the business owners could do that?

Code Enforcement Report, Gary Post present - A report was presented. 1) The Dollar General is proceeding forward. He has gone through the building plans. They figure to be starting within 2 weeks. He got the sign-off sheet from SHPO. 2) Gary met with DEC regarding flood plain management. There is one issue that needs our attention and we're working on it. He met with DEC on July 12<sup>th</sup> and spent many hours with them. We are waiting for a letter from them. 3) Gave out a permit for a garage that is going up on Grove Street. 4) Gary's been working on ISO. It's what all insurances are based on in the United States. David stated that they have been out to meet with the fire company to check the water flows at the hydrants. 5) Gary has been meeting with the gentleman who just bought 61 Grove Street. He got a building permit. 6) He has been working with the new store across the road that is just opening up. 7) Trustee Bob Bennett asked if we were going to get any surprised when they demo the Hotchkiss house for the Dollar Store. Gary stated that it was all taken care of before this. 8) Gary wrote violations for the alleys between buildings for both 112 Main Street and 116 Main Street. 9) David stated that he got a UPO notice for a garage at 30 King Road. Gary said that he has not issued a building permit for it. David will get in touch with the contractor and have him call Gary. 10) Trustee Tom asked where things stand with the house that was tore down on Maple Ave. Gary stated he called them but they have not got back to him yet

**Attorney Report** - A report was submitted. 1) Trustee Bob West asked if things are moving forward with the Village Green. They mayor stated that our attorney needed some information that had to come from the church session. 2) Mayor Harting had the attorney check into a legal clause

that would require them to file certain paperwork before they could close.

Streets Report, David Decker present - 1) David met with Broome Bituminous but still has not given a price for the streets or for the sidewalks on Academy Street. 2) They got truck prices from Chenango Sales. They are within \$400 of state bid. The cost is \$27,500. The trade-in amount for the 2010 truck is \$12,500. They would take the plow and wing off the old truck. It would cost \$290 for a plastic bedliner installed.
