County Report - Scott is still working on the issues he discussed with the village board last month. He would like to set up a meeting with Dave Hamlin, the mayor, the clerk and himself. He said we may see an increase in the county taxes because of the low sales tax revenues. He stated the bridge issue on Chestnut Street is going to be resurrected. That needs to be fixed as it's in bad shape. He stated if Sanford and Deposit use that road, they should also contribute towards the repair. Scott asked if Depot Street could be opened as it once was. maybe as a temporary road.

West Code Enforcement Report, Gary Post present - 1) Things seem to be going good at the can redemption center. Scott stated that Dana offered Iva Jean Tennant 7.5¢ per can for a scholarship fund that she is collecting cans for in memory of her granddaughter. Bob Bennett spoke with Dana and he said he would give them 6¢ per can for their Cans for Campership at the Methodist Church. 2) Gary has been in touch with the prospective buyer of 185 Main Street. The mayor also spoke with them, as they want to donate some of the property to the village.

Streets Report, David Decker present - 1) Broome Bituminous should be in this month to pave Grove Street. The plant is open until Thanksgiving. 2) The last day of brush pickup is November 3rd. It needs to be put in the paper. 3) We need to get tires for the pickup. I'm looking at several places for prices. 4) David strongly feels we don't need to hire anyone before spring. 5) The signs have been ordered for Church and Dewey Streets and the rest of the ones ordered earlier this year. They lost the past order. We're using a new company now as they have lost that order twice.

Water Report, David Decker present - 1) I'm reading meters the next couple weeks. 2) Hydrants will be flushed on November 3rd, 4th & 5th. A notice needs to be put in the Windsor Standard. 3) The water leak is fixed at Marian's. We are saving approximately 100,000 gallons of water a day. We were able to leave the valve in place to get the job done and it was a regular style gate valve. Marian hasn't had water pressure like this in 22+ years. 4) The fluoride equipment grant is progressing. We should hear by the end of the month.

Treasurer's Report, Patricia Harting present - 1) A report was presented. We're pretty much on schedule with everything. We had a large expense this month with the water leak at Marion's. But we're saving money by having it fixed.
