## RESOLUTION NO.26-2018 ADOPTING LOCAL LAW NO.2 OF 2018

**WHEREAS,** a resolution was duly adopted by the Village Board of Trustees of the Village of Windsor for a public hearing to be held by said Board at the Community House, 107 Main Street, Windsor, New York at 6:00 p.m. on Tuesday, December 19, 2018, to hear all interested parties on a proposed Local Law No.2 for 2018 authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c; and

**WHEREAS**, notice of said public hearing was duly advertised in the Windsor Standard on December 12, 2018; and posted on the Village Clerk's Sign Board on December 7, 2018; and posted on the Village website on December 7, 20188; and

**WHEREAS**, said public hearing was duly held at the Community House, 107 Main Street, Windsor, NY at 6:00 p.m. on December 19, 2018, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and

WHEREAS, the Village Board of Trustees of the Village of Windsor, after due deliberation, finds it in the best interest of the Village to adopt said Local Law,

**NOW, THEREFORE, BE IT RESOLVED,** that the Village Board of Trustees of the Village of Windsor hereby adopts said Local Law as Local Law No.2of 2018, a copy of which is attached hereto and made a part hereof, and

**RESOLVED** that the Village Clerk be and she is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Village of Windsor, and to give due notice of the adoption of said Local Law to the Secretary of State; and

#### Local law #2-2018

Be it enacted by the Village Board of the Village of Windsor as follows:

## Section 1. Legislative intent

It is the intent of this local law to allow the Village of Windsor to adopt a budget for the fiscal year commencing March 1, 2019 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c

#### **Section 2. Authority**

This local law is adopted pursuant to subdivision 5 of General municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing board.

## Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Windsor, located in the County of Broome, is hereby authorized to adopt a budget for the fiscal year commencing March 1, 2019 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

#### Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

**Budget discussion** - The board was presented with the taxable evaluation. They discussed a small increase of 1.2%. The allowable tax cap is 1.04%.
