Grant Writer Report, Steve Contento present - 1) We have not heard about the Safe Routes to School grant. He's looking at another local foundation for the RR station grant. NYSERDA grant is still available for appliances if we want to apply for them. They'll pick up 75% of the cost. It has to be an energy efficient appliance.

Code Enforcement Report, Gary Post present - 1) A letter was sent to the owner at 116 Main Street regarding making a first floor apartment after a one year vacancy. The apartment on the south side was vacant because of the health department closing for 2 years. The owner is upset because it wasn't his fault that the building was empty. The village law doesn't state about any circumstances of the vacancy, just that it's a year. Gary told him he could go to the village board if he wanted. Trustee Skinner asked if the health department has cleared the building. Gary stated that he called the Broome County Health Department and at this time, he does not know. Tom also asked if he had gotten a building permit. Gary stated yes. 2) Gary got a call from a lady regarding McBride's. She is considering purchasing the building and opening it back up as a restaurant. 3) The parsonage for the Methodist will be getting a new garage. It will depend upon when Colwell's has the time. It will be moved over a little from the present one. They have a permit. 4) Sent out some violations. 5) Haven't heard anything from 185 Main Street. 6) We received a written complaint regarding 23 Academy Street. Gary wrote them up last Saturday.

Attorney's Report - No report was submitted.

Streets Report, David Decker present - 1) The new Kubota is in. The cab will be here in about 4 weeks. 2) Had to get a couple new batteries for the dump truck. 3) Everything is ready for the winter. The salt spreader is in. 4) The zero-turn is up to Oliver's. They are going to give us a price for a new one. 5) the John Deere will go out to bid for bids to be opened up at the January meeting. It was suggested to put in newspapers other than the Windsor Standard.

Water Report, David Decker present - 1) The hydrants are all flushed and ready for the winter. The parts for the bleed-offs are still not here. 2) Jim Masser from the NYSDOT sent a Memorandum of Understanding for us to use the state salt bin that is located on Rt.17 west, out of the village. This MOU describes the hours, salt usage and equipment hour usage. We would pay the cost of the salt plus 10% for use of equipment to use their tractor. For this year, we will finish up what salt we have on Bridge Street. The NYSDOT is still working on possibly us using the property across the road from the pumphouse.
